1. Attendance

- b) Apologies: Chris Spearing (Treasurer); Peter Walton (v- Pres.) Andrew Gardeners repeat absence was noted. It was suggested that he may be out of the country on official national golf duties.

2. Previous Minutes -

- a) Minutes of Committee Meeting 10th April 2024 were accepted and signed by the Captain.
- b) Matters Arising;
 - 3 b) iv) The analysis of the capabilities and benefits of IG against our current and likely future needs. (T Killick: K Henley, assisted by C. Whittle, P. Walton & R. Sillence ongoing)
 - 5 a) Re the practice of some host Clubs to charge for the use of meeting rooms for Committee Meetings; action was agreed for Roger Sillence to review the location of these Meetings through the 2025 Fixtures List to favour those host Clubs that do not charge for these facilities.

 Initial action was taken to relocate the 2025 Spring Meeting from Burford to North Oxford.

 - 5 b) The suggestion that a restriction of team size to 16 for inter-county Matches, regarding the increasing absence of 2-tee starts, to be discussed with the other Counties.

(Roger Sillence - ongoing)

- 5 c) Peter Walton raised the question of gaining sponsorship for our golf Fixtures. This to be given due consideration by all attendees of the Meeting. (All ongoing)
- 8 a) To resolve the problem of inferior quality of jumpers, Members will be offered an embroidery service for application of the OGC badge to Member-purchased jumpers (likely to cost £6 ea.). An email, prepared by Glyn Hall offering this service, was circulated to Members by the Secretary on 3rd May 2024. (closed)
- 10 c) Owing to Malcolm Hookham's restricted activity at North Oxford through ill health, a replacement OGC Representative should be recruited.
- Bill White discussed with Malcolm Hookham who agreed to the change and proposed that Andy Quinn could be his replacement. When approached, Andy agreed to take on the role of OGC Representative at North Oxford GC. (closed)
- 10 d) It was suggested that the lack of recruitment of Members at Henley GC over the last 6 years should be investigated

Bill White discussed the recent lack of recruitment at Henley GC with Geoff Luckett (OGC Rep at Henley). He explained that recent Captains and at Henley have been young and hence they have not shown interest in joining the OGC this being due to lack of available free time from work and club commitments. 6. Match Secretary's Report

a) Report Item e). The whereabouts of the Winning Team trophy for the Four Counties match? Ray Davies and Keith Henley to continue the search for it.

If the trophy cannot be found a new one will be require to be purchased. Also, the "new" trophy will require to be engraved. Keith Henley will investigate options for engraving and establish a "process" for future trophy engraving.

Post Meeting Note: Ray Davies subsequently found the Four Counties Trophy at Oxford (City) G.C.

b) 2024 Four Counties match.

This match will be hosted by OGC at Studley Wood. Ray Davies suggested that we source two volunteers for meet and greet and to act as starters.

Ray also asked whether complimentary food will be provided for the starters?

Post meeting Note: It was agreed with the Treasurer that starters will not pay for food.

7. Event Secretary's Report

a) Founders Cup (The Springs G.C.)

Essex guests have asked for advice on local accommodation. It was noted the Springs Hotel was an option. (S. Dobbs)

b) Captains Day (Badgemore Park G.C.)

Stuart Dobbs advised that a two tee start for this event had not been granted by the host club. At the time of this meeting, 26 entries had been received.

At the time of this meeting 11 pairs had entered.

8. Clothing Report

10. AOB

a) By email on 16th April, Glyn Hal proposed that OGC Club Representatives should be invited to the annual Committee Dinners. Notwithstanding dissentions received from Chris Spearing, Roger Davies and Tim Nunneley, the benefits of this proposal were discussed i.e. bolster the reducing attendance*; demonstrate that the Representatives are valued, introduce potential candidates for service on the Committee; no cost impact (self-funding event), etc. It was noted that some Representatives are already on the invitation list (e.g. had served or currently serving on the Committee). The proposal was subsequently voted upon and was agreed on a majority basis.

- b) Roger Sillence updated the Committee on the introduction of green fee charges for OGC fixtures by Henley G.C. in 2025. It was understood that this was discussed at the Henley Pat Captains AGM on 21 June 2024 and continuation of "Captain's privilege" was passed on a 9 to 4 majority. Roger Sillence has prepared a draft letter to the James Brockington (General Manager at Henley G.C.) in readiness to respond to the introduction of such charge. However, as internal discussions are still ongoing with the General Manager, it was agreed to hold any further action at this time.
- c) Ray Davies advised of an instance where, at an OGC Fixture, he decided to select a sandwich lunch (instead of bacon rolls as previously agreed in Committee), because there was no decrease in cost thereof. This deviation from the agreed way forward was discussed at length. It was agreed that, for consistency, bacon roll lunches will continue to be ordered and served at fixtures and that deviation to an alternative lunch menu would only be acceptable if the host club declares their inability to serve these.

The meeting was closed at approximately 11:49 am.

 "7) Every competitor's WHS handicap index will first be adjusted relative to the slope rate, course rating and par of the golf course on which they are competing. This will produce each competitor's unrounded course handicap, to which 85% will then be applied and the figure then produced, rounded to give the competitor's playing handicap. A higher handicapped player may take part but must do so with a maximum playing handicap of 18 strokes."

Please find 2 reports for our next committee meeting.

Inter Counties Competition

Unfortunately, with drop outs and new Captains joining. We are still revolving around 8 players, so as needing 12 with reserves we are having to with draw from, , this competition this year.

OGC Clothing.

Ordering for clothing is again very slow, we are currently waiting for a delivery for 3 Blazers, for 3 new Captains, and potentially have another blazer on the list, as production now require 3 blazers to be ordered to avoid a delivery charge.

As always, due to my expertise with the spread sheet, there are a couple of outstanding stock checks to be clarified, with regards safe delivery to the individual Captain.

There has also been a bit of a blip surrounding the presentation of Captains ties. It has been resolved that we are going back to the past method of dealing with these requirements.

I have been having trouble getting hold of Andy Gardiner, if any committee members has information about him, please could you pass this on to me.

Once stock and spread sheet have been reconciled, I will provide a list to Captain White of remaining stock of jumpers and vests for Captains to order on a first come first serve basis, for publication to the membership.

We will still hold stock of OGC Polo Shirts.

I will also provide Captain Whittle with an online catalogue address to be broadcast on the clothing page of the OGC website, along with information. It belongs to our current provider and embroiderer.

The change that is being made, will allow Captains to source their own suitable golf clothing, i.e. white polo shirts and Navy jumpers, vests and other tops that are suitable to wear for golf, to then be embroidered under OGC control, with the OGC Log.

2 past Captain of Captains have successfully taken advantage of this opportunity. It allows for captains to take advantage of special offers by manufacturers which would not be suitable for us to manage.

Not that anyone else will be aware of this, but due to our blazer supplier having another hiccup with efficiency of supplying the latest order, I have found another supplier, based in Didcot, who maybe able to help us sourcing in the future. Once the new blazers arrive, I will show them a sample and see if they can be an alternative source.
